

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is entered at Patna on dated 16-10-2023 (effective date).

BETWEEN

AND

We had a clear Perception about our educational efforts to establish a women's College in the Vicinity

Karo Sambhav and Rameshwar Das Pannalal Mahila College, Patna shall hereinafter be individually referred to as a "Party" and collectively be referred to as the "Parties".

Recitals:

a) Whereas Karo Sambhav is in the business of, among other things, providing environmental compliance services and e-waste management solutions to producers and generators including bulk consumers operating in India. Karo Sambhav works on behalf of and with electronics producers to keep obsolete discarded electronic products out of landfills, to optimize the recovery of resources from electronic products or their components, and to develop a globally harmonized and locally relevant system for responsible e-waste management in India.

b) And whereas Rameshwar Das Pannalal Mahila College, Patna Parties believe that raising awareness, setting up of collection infrastructure and ensuring responsible recycling of waste from electrical and electronic equipments (WEEE) is of utmost importance and want to collaborate and implement programmes in this area.



In furtherance of the above, it's Parties' desire to conclude MOU that is flexible under which Karo Sambhav and Rameshwar Das Pannalal Mahila College, Patna shall collaborate on sustainability programmes geared towards E-Waste time to time.

Now this "MOU" witness as follows:

1. Purpose of this Agreement

Parties agree to mutually work towards responsible recycling of E-waste generated and/or collected by Rameshwar Das Pannalal Mahila College, Patna and handed over to Karo Sambhav towards responsible recycling. Under this, the Parties agree to do the following:

2. Role and Responsibilities

- 2.1.** Ensure collection of E-waste (as per products part of Karo Sambhav's portfolio mentioned in Annexure: 1) from Rameshwar Das Pannalal Mahila College, Patna.
- 2.2.** Provide a certification of pickup and responsible e-waste management and recycling through Karo Sambhav a Producer Responsibility Organization.
- 2.3.** Provide awareness material for dissemination to the employees and staff of Rameshwar Das Pannalal Mahila College, Patna in organizing awareness drives.

- 2.6.** Disseminate awareness material on responsible recycling of E-waste provided by Karo Sambhav.
- 2.7.** Ensure that the employees are aware of the E-waste items which are to be shared with Karo Sambhav.
- 2.8.** Conduct Awareness programme on e-waste management at the college campus followed by collection drive for all their employees and students once in a financial year.


