In exercise of the power conferred upon the Vice-Chancellor by section-58(1) of the Bihar State Universities Act, 1976 as amended upto date and in pursuance to the order of the Chancellor communicated vide Governor's Secretariat letter no BSU/03/2000/1207/GS(1) dated 24/6/2003 & BSUSC/03/2003-1995/GS(1) dated 7/8/03 and on the basis of the requisition sent by the University to the Bihar State University (Constituent Colleges) Service Commission, Patna and its recommendation vide letter No 28/Conf/BSUSC dt.20/11/02, 37/Conf/BSUSC dt.27/11/02 & 51/Conf/BSUSC dt.29/11/02, the Vice-Chancellor has been pleased to order the appointment of the following persons as lecturer on a purely temporary basis in the subject noted against their names in the admissible pay scale and other allowances as per rules of the University, subject to the conditions that the appointment is liable to be terminated without prior notice, if the selection made by the Commission is declared illegal either by competent authority or by an order of any competent court and payment of salary will be made only on receipt of grants from the State Govt. for these appointed teachers.
