Notification

The Vice Chancellor in exercise of the powers conferred on him under section 57 of the Bihar State Universities Act 1976 (as amended up to date) and also under the provisions of clause-5 of the statutes as assented by H.E. the Chancellor vide Governor's Secretariat letter no. BSU-23/2007-2187/GS(I) dated 30.06.2008 and on the recommendation of Selection Committee, has been pleased to appoint following persons as Principal of constituent colleges under Magadh University Service on the prescribed pay scale with admissible allowances as per rules. They are directed to join in the office of Registrar with proper N.O.C. and relieving of employer within 60 days from the issue of this notification- failing which their claim shall not be entertained. Probation period will be for two years as per M.U. Service rules. In case of verification, if any information/certificate is found false the appointment shall be cancelled. In case of any legality the direction of Hon'ble Court will be followed. If any charge or misappropriation and irregularities are found by any Govt. agency or Vigilance the appointment shall be declared null and void. No. T.A. shall be paid for joining the post.
